Explanation

Rushwick Parish Council is in the transition period to operate its own website. It has engaged the services of INL Group Limited to develop a new website following the announcement that the Worcestershire County Council MyParish web portal is to be withdrawn on 1st September 2026. As the MyParish platform utilises outdated technology and does not meet the required Web Content Accessibility Guidelines (WCAG 2.2AA) for public sector websites.

The new Parish Council website is currently under construction with a logo design and content and layout currently under implementation. All of the content from the existing website has been securely backed up. The first 25% stage payment has been made.

Rushwick Parish Council has adopted an IT Policy.
